- 2 Other income includes Profit on Sale of Windmill Land situated at Aralvaimozhi, Tamil Nadu for Rs.552.96 lakhs for year ended 31st March, 2024, out of which Rs. 511.48 Lakhs pertains for the Quarter ended 31st March, 2024.
- These standalone financial results are prepared in acccordance with the recognition and measurment principles of Indian Accounting Standard as prescribed under Section 133 of the Companies Act, 2013 read with Companies (Indian Accounting Standards) Rules, 2015 as amended.
- 4 The Company has organized its business into three segments as Tea, Power and Investments which is in conformity with the Indian Accounting Standard (Ind AS-108-Operating Segment) on "Segment Reporting" principles.
- Figures of the quarter ended 31st March, 2024 and 31st March, 2023 are the balancing figures between audited figures in respect of full financial year and published year to date figures up to the third quarter of the relevant financial year.
- The Board of Directors at its meeting held on 09th November 2023 have approved the disposal of its Wholly Owned Subsidiaries PKT Plantations Limited for a consideration of INR 40 Lakhs and Shivphal Vinimay Private Limited for a consideration of INR 5 lakhs, net of all liabilities taken over by the buyer M/s Maharaja Shree Umaid Mills Limited which is a related party and the said transactions are at arm's length price.
- 7 Depreciation for the year ended 31.03.24 includes Rs.55.78 lakhs related to prior period from FY 2017-18 to FY 2022-23 on account of reclassification of Asset
- 8 Previous period's figures have been regrouped / rearranged, to the extent necessary, to confirm to current period's classifications.
- 9 The Board of Directors has recommended a dividend payment of Rs. 1 /- Per Share (Face value of Rs. 10/- each) for the Financial Year ended March 31, 2024.
