## # Clarification Note for Intimation for inter-se change in the shareholding of the promoter group entities on account of Scheme of Amalgamation

This is to inform you that Maharaja Shree Umaid Mills Limited ("MSUM"/ "Transferee Company"/ "Acquirer"), on January 2, 2025 informed the Company that they have acquired 1,21,275 Equity Shares of The Peria Karamalai Tea & Produce Company Limited ("MSUM"/ "Transferee Company"/ representing 3.9173% of the total paid-up equity share capital of the Target Company vide their Disclosure under Regulation 29(1) and 29(2) of Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 20II (the "Takeover Regulations,") and Regulations (7(1)(b) and 7(2)(a) of the Securities and Exchange Board of India (Prohibition of Insider Trading) Regulations, 2015, pursuant to Scheme of Amalgamation between 33 Group Companies (Transferor Companies) with MSUM, which was sanctioned and approved by the Hon'ble NCLT vide its Order dated October 23, 2024 under section 230 to 232 of the Companies Act, 2013.

Out of the 33 Transferor Companies, the following 1 Transferor Company, which was forming part of the promoter group of PKTPL and was holding equity shares of PKTPL as detailed herein below:

On account of the aforesaid Scheme of Amalgamation, the above named 1 Promoter Group Company has been inter-alia merged into MSUM and accordingly 1,21,275 equity shares representing 3.9173% of PKTPL held by aforesaid 1 Promoter Group Company stand transferred to Maharaja Shree Umaid Mills Limited. Accordingly, Maharaja Shree Umaid Mills Limited has become a part of the Promoter Group of the Company in place of afore-mentioned 1 earlier promoter Group Company of PKTPL. Further, the aforesaid acquisition, being pursuant to transfer of shares amongst the existing promoter group, does not result in any change in the aggregate shareholding of the promoter and promoter group of PKTPL. Further, this is to clarify that holding of 1,21,275 equity shares representing 3.9173% are still lying in the name of the aforesaid Transfero Company and not in the name of Maharaja Shree Umaid Mills Limited in the benpos data downloaded by the Registrar & Share Transfer Agents ("RTA") from both the Depositories i.e NSDL & CDSL as on 31.12.2024 for the Stock Exchange as these are in the process of transfer. Hence, the Company is submitting the shareholding pattern as on 31.12.2024 by giving the details of holding of the aforesaid Transferor Company as appearing in the benpos data received from the depositories.
